MEMORANDUM FOR ALL JB CHS PERSONNEL

SUBJECT: Partial Termination of Limited Evacuation Order

1. As the Commander of Joint Base Charleston, under the authority of the Joint Travel Regulation (JTR) paras. 0601, Table 6-2, 0602 and 0604, I ordered an evacuation effective on 10 September 2018 at 1800 for evacuees residing in the following areas: Northern Coast (All Zones) including Horry County Evacuation Zones A, B, C and Georgetown County Evacuation Zones A, B, C; Central Coast (All Zones): Charleston County Evacuation Zones A, B, C, Dorchester County Evacuation Zones D, E, F and Berkeley County Evacuation Zones B, G, H, I; Southern Coast (All Zones) Colleton County Evacuation Zones A, B, Beaufort County Evacuation Zone A and Jasper County Evacuation Zones A, B; and those evacuees whose permanent residence was located outside of these counties but were ordered by command to evacuate.
2. At approximately 1100 on 11 September 2018, the Governor of South Carolina rescinded the mandatory evacuation order for Colleton County Evacuation Zones A, B, Beaufort County Evacuation Zone A and Jasper County Evacuation Zones A, B excepting the residents of the barrier island of Edisto Beach in Colleton County. On 15 September 2018, the Governor of South Carolina rescinded the mandatory evacuation for Central Coast (All Zones) including Charleston County Evacuation Zones A, B, C, Dorchester County Evacuation Zones D, E, F and Berkeley County Evacuation Zones B, G, H, I and Edisto Beach. This change to the Governors evacuation order did not rescind the evacuation of Georgetown and Horry counties.
3. As a result, as of 1200 on 15 September 2018, I am terminating the evacuation order and issuing a recall order for personnel in the Central Coast (All Zones) including Charleston County Evacuation Zones A, B, C, Dorchester County Evacuation Zones D, E, F and Berkeley County Evacuation Zones B, G, H, I; Southern Coast (All Zones) including Colleton County Evacuation Zones A, B, including Edisto Beach, Beaufort County Evacuation Zone A and Jasper County Evacuation Zones A, B; and those evacuees whose permanent residence was located outside of these counties but were ordered by command to evacuate. After the Governor of South Carolina rescinds all evacuation orders, a separate Joint Base Charleston termination order will be provided for the evacuees of the Northern Coast (All Zones) including Horry County Evacuation Zones A, B, C and Georgetown County Evacuation Zones A, B, C. These areas are still under a mandatory evacuation order issued by the Governor of South Carolina.
4. All personnel in the zones listed in Paragraph 3 are hereby ordered/authorized to return to their residence and soon as possible but when it is safe to do so given the weather and road

conditions from their safe haven location to their residence but no later than 2359 (11:59 pm) Eastern Time, 18 September 2018. At that time, all claimable travel, lodging, and per diem entitlements will cease. I will approve any requests for exceptions to the authorized entitlements, due to extenuating circumstances, on a case-by-case basis. If unable to return safely or by the designated return time, personnel must request an exception to this order through their chain of command to me. Additional guidance regarding travel voucher processing will be published by the servicing Finance office.

5. This order does not apply to personnel detailed to SPAWAR Systems Center Atlantic (SSC LANT). SSC LANT personnel should follow guidance from the activity head.

6. All affected members should contact to their chain of command for questions or further instructions.
